Introducing my new Flight Review program for pilots around Rochester: Most of you know I only do Flight Reviews through the FAA's WINGS Pilot Proficiency Program. I do this because WINGS is such a great program for keeping pilots current. There are three "Flight Activities" with a list of maneuvers to be flown with a CFI to complete the equivalent of a flight review. I'm offering pilots these three sorties at only \$15 per sortie and spaced about 120 days apart. These rides can be as long as you want. ## "Airman Certification Standards (ACS) Explained"

Topic: New Airman Certification Standards (ACS). Post maintenance flight tests. On Wednesday July 13, 2016 at 18:00 Central Daylight Time Click for more information.

# Description:

The FAA and industry have partnered together to develop the replacement for the Practical Test Standards. The Airman Certification Standards bring substantial improvements to the certification process. This seminar will provide background on how the ACS was developed and explain how ACS will be used during both the knowledge tests and the practical tests.

There will also be a brief safety presentation on how and when to conduct a post flight check after any maintenance is performed on an aircraft. Actual case history of incidents and accidents that have occurred during the first flight after maintenance.
